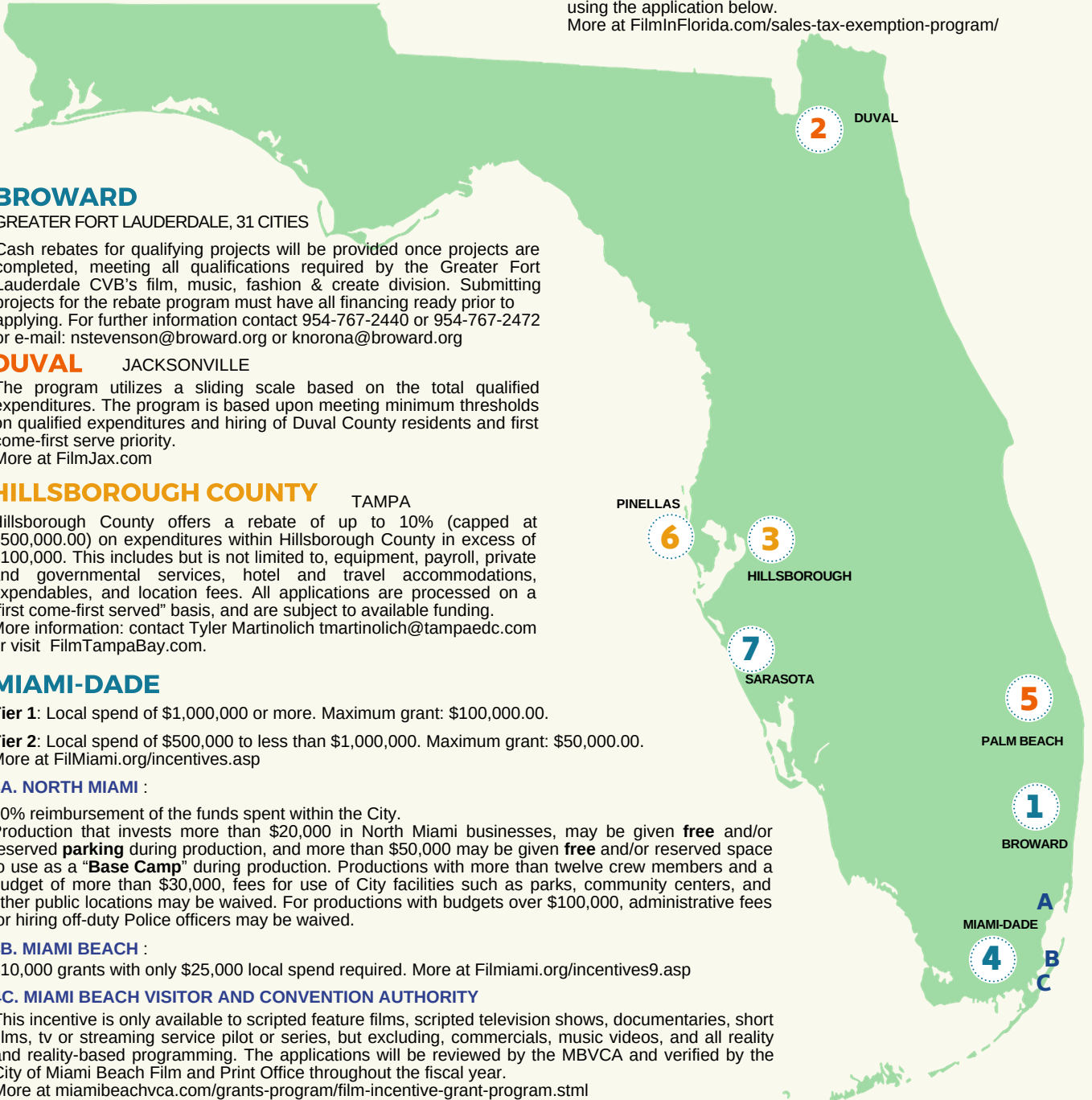




FLORIDA FILM INCENTIVES

Any qualified production company producing motion pictures, made for television motion pictures, television series, commercial advertising, music videos or sound recordings in Florida, may be eligible for a sales-and-use tax exemption on certain production related purchases in Florida. To be exempt from Florida's sales tax at the point of sale, the production company must apply for a certificate of exemption using the application below. 1. BROWARD

GREATER FORT LAUDERDALE, 31 CITIES

Cash rebates for qualifying projects will be provided once projects are completed, meeting all qualifications required by the Greater Fort Lauderdale CVB's film, music, fashion & create division. Submitting projects for the rebate program must have all financing ready prior to applying. 2. DUVAL JACKSONVILLE

The program utilizes a sliding scale based on the total qualified expenditures. The program is based upon meeting minimum thresholds on qualified expenditures and hiring of Duval County residents and first come-first serve priority. More at FilmJax.com

3. HILLSBOROUGH COUNTY TAMPA

Hillsborough County offers a rebate of up to 10% (capped at \$500,000.00) on expenditures within Hillsborough County in excess of \$100,000. This includes but is not limited to, equipment, payroll, private and governmental services, hotel and travel accommodations, expendables, and location fees. All applications are processed on a "first come-first served" basis, and are subject to available funding. 4. MIAMI-DADE

Tier 1: Local spend of \$1,000,000 or more. Maximum grant: \$100,000.00.

Tier 2: Local spend of \$500,000 to less than \$1,000,000. Maximum grant: \$50,000.00.

4A. NORTH MIAMI :

30% reimbursement of the funds spent within the City.

Production that invests more than \$20,000 in North Miami businesses, may be given **free** and/or reserved **parking** during production, and more than \$50,000 may be given **free** and/or reserved space to use as a "**Base Camp**" during production. Productions with more than twelve crew members and a budget of more than \$30,000, fees for use of City facilities such as parks, community centers, and other public locations may be waived. For productions with budgets over \$100,000, administrative fees for hiring off-duty Police officers may be waived.

4B. MIAMI BEACH :

\$10,000 grants with only \$25,000 local spend required. More at FilMiami.org/incentives9.asp

4C. MIAMI BEACH VISITOR AND CONVENTION AUTHORITY

This incentive is only available to scripted feature films, scripted television shows, documentaries, short films, tv or streaming service pilot or series, but excluding, commercials, music videos, and all reality and reality-based programming. The applications will be reviewed by the MBVCA and verified by the City of Miami Beach Film and Print Office throughout the fiscal year.

5. PALM BEACH COUNTY WEST PALM BEACH - JUPITER - BOCA RATON

Tourism Branded Content Sponsorship Program's initiates and sponsors positive tourism branded programming that aims to attract and increase tourism to The Palm Beaches. A total of \$650,000 is available for sponsorships. Distribution must be in place. 6. PINELLAS COUNTY ST. PETERSBURG- CLEARWATER

This local incentive program pays an agreed-upon amount to qualifying production companies in return for specific promotional commitments to the St. Petersburg-Clearwater, Florida area. Grants typically range from \$10,000-\$200,000. For more visit Filmspc.com/

7. SARASOTA COUNTY

Sarasota County offers a unique rebate for Local production and post-production of Film,Commercials, TV, web, print and other media of up to 100% cash rebate on Sarasota County Government fees and services PLUS up to 20% cash back on qualified expenditures for goods and services in Sarasota County up to a total combined \$25,000.00.
